DIRECTORY LISTING INFORMATION

Each line in the directory costs \$10. **There is a three-line minimum;** the first two lines should include the name of the business, the phone number, and the address. Additional lines could include other information about the business: e-mail address, website, products offered, Facebook username, descriptive directions, a slogan or tagline, etc. There is a maximum of 30 characters per line, including spaces. The purchase of a display ad gets you three lines in a directory listing free of charge, a \$30 value.
